“Allotment of fancy No. may be made to the last No. of the series in which Numbers are assigned, say like PY-01/B-9999 at present in respect of Pondicherry and Karaikal regions and upto 3000 Numbers immediately following the Number registered in the serial order in respect of Mahe & Yanam regions”.

The Transport Commissioner is therefore requested to send the proposals for the allotment of Registration Numbers which satisfy the above conditions.
