NOTIFICATION

WHEREAS, by notification issued under (1) G.O.Rt.No.15/96-Wel.(Tr.), dated 22nd July, 1996 of the Chief Secretariat (Transport), Pondicherry, (2) G.O.Ms.No.10/2001(Tr.) dated 23rd October, 2001 of the Transport Department (Secretariat Wing), Pondicherry and (3) G.O.Ms.No.34/2004-(Tr.), dated 26th August, 2004 of the Transport Department (Secretariat Wing), Pondicherry, the Motor Accidents Claims Tribunals and Additional Motor Accidents Claims Tribunal were constituted for all the four regions of this Union Territory for the purpose of adjudicating upon claims for compensation in respect of accidents involving death of, or bodily injury to persons, arising out of the use of motor vehicles, or damage to any property of a third party so arising or both;

AND WHEREAS, the Hon'ble High Court of Judicature at Madras after taking into consideration of the number of cases that are pending in Pondicherry region and the number of case that are being filed every month has recommended for constitution of one more Additional Motor Accidents Claims Tribunal to be headed by a single member in the cadre of Civil Judge (Senior Division) for the trial of MACTOP cases at Pondicherry, in addition to other Motor Accident Claims Tribunal functioning in Pondicherry.



NOW THEREFORE, in exercise of the powers conferred by sub-sections (1) and (2) of Section 165 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Lieutenant-Governor, Pondicherry is pleased to constitute one more Additional Motor Accidents Claims Tribunal at Pondicherry region to be headed by a single member in the cadre of Civil Judge (Senior Division) for the trial of MACTOP cases at Pondicherry, in addition to other Motor Accident Claims Tribunals functioning in Pondicherry and appoints the Presiding Officer (Sub-Judge) posted as a single member of the said Additional Motor Accidents Claims Tribunal for the purpose of adjudicating upon claims for compensation in respect of accidents involving death of, or bodily injury to persons arising out of the use of motor vehicles, or damage to any property of a third party so arising or both, in Pondicherry region and for the said purposes, hereby makes the following amendment to the Notification issued under G.O.Rt.No.15/96-Wel.(Tr.), dated 22nd July, 1996 of the Chief Secretariat (Transport), Pondicherry and published in the official Gazette No.32 dated 6th August, 1996, namely:-
