CIRCULAR

Sub: TD – Fitment of anti lock braking system or Combined braking system conforming to IS: 14664:2010 for vehicle models of category L2 -Communicated - Reg.

Ref: G.O No. G.S.R. 310(E) dt. 16-03-2016 of the Ministry of Road Transport & Highways, New Delhi.

With reference to the subject cited above, in exercise of the powers conferred by section 110 of the Motor Vehicles Act, 1988 (59 of 1988), the Central Government hereby makes the following rules further to amend the Central Motor Vehicles Rules, 1989.

2. In this connection it is stated that in the Central Motor Rules, 1989, in rule 96, after sub-rule (4), the following sub-rule shall be inserted, namely:-

“(4 A) Notwithstanding anything contained in clause (i) of sub-rule(4) , -

(a) New vehicle models of category L2 with;

(i) engine capacity \leq 125 cc;

(ii) maximum continuous rated or net power \leq 11kw;and

(iii) power/weight ratio \leq 0.1 kw/kg,

manufactured in and after the 1st April, 2018 shall be fitted

with anit-lock braking system or combined braking system

Conforming to IS: 14664: 2010;

(b) Existing vehicle models of category L2 with :

(i) engine capacity \leq 125 cc;

(ii) maximum continuous rated or net power \leq 11kw;and

(iii) power/weight ratio \leq 0.1 kw/kg,

manufactured in and after the 1st April, 2019 shall be fitted

with anit-lock braking system or combined braking system

conforming to IS: 14664: 2010;

Provided that all other category of two wheeled vehicles which does not fall in the criteria as mentioned above in clause (a) and (b) shall be fitted with anti-lock braking system (ABS) conforming to IS: 14664: 2010 on and after the 1st April, 2018 for new vehicle models and on and after the 1st April, 2019 for existing vehicle models.”

L2- means a motor cycle as defined in sub-section (27) of section 2 of the Act, with maximum design speed exceeding 45 km/hour and engine capacity exceeding 50 cc, if fitted with a thermic engine.

3. The principal rules were published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i) vide notification number G.S.R 590E, dated the 2nd June, 1989 and last amended vide notification number G.S.R 188(E), dated the 22nd February 2016.
