
In exercise of the powers conferred by sub-section (1) of Section 200 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988) read with G.O.Ms.No.17/92-Wel(Tr), dated 12.5.1992 of the Chief Secretarial (Transport), Pondicherry, the Lieutenant Governor, Puducherry hereby specifies that the offences punishable under section mentioned in column (2) of the Table below, in respect of transport vehicles only, may either before or after the institution of prosecution be compounded by any officer not below the rank of inspectors of the Puducherry Road Transport Corporation, as specified herein for the amount specified in the corresponding entry under column (3) of the said table.

**TABLE**

SI No. (1)	Section under which the offence is punishable (2)	Compounding amount of the offence (3)
1	Section 178 (1)	Rs. 500/-
2	Section 178 (2)	Rs. 500/-

2. Whoever is charged in the above said offence shall have to pay the fine on the spot itself to the officer as specified above and on receipt, the amount shall be remitted into the account of Puducherry Road Transport Corporation, Puducherry. The person who fails to pay the amount shall be removed from the Stage Carriage by the driver or the Conductor or by a Police officer on the request of the driver or conductor and shall be handed over to the nearest Police Station, for taking action against such person under Section 178 of the Motor vehicles Act, 1988.
